JOINT AND UNANIMOUS RECOMMENDATION FOR APPOINTMENT OF PLAINTIFFS' LIAISON COUNSEL

COME NOW, Paul Pennock of MORGAN & MORGAN, Bijan Esfandiari of BAUM HEDLUND ARISTEI & GOLDMAN, and Rachel Lanier of THE LANIER LAW FIRM, each having filed their respective applications for leadership positions in this matter, and submit this Joint and Unanimous Recommendation of Allison Mullins of the Turning Point Litigation firm for appointment as Liaison Counsel for Plaintiffs in the above-captioned MDL proceeding. This Joint and Unanimous Recommendation is submitted pursuant to Paragraph 5 of the Court's First Pretrial Order (ECF No. 24). In support hereof, the undersigned shows the following:

1. As directed by the Court's First Pretrial Order, the undersigned counsel for Plaintiffs conferred and sought consensus with as many of the other known counsel who are representing individual Plaintiffs in this MDL proceeding as was practicable. Specifically, the undersigned counsel reached out to other plaintiffs' counsel by email and conducted multiple video conference calls in which various issues related to this MDL were discussed, including candidates for appointment as liaison counsel.

2. Through these various efforts to confer, it became clear that Ms. Mullins was the

best and unanimous choice to serve as liaison counsel in this MDL proceeding. Ms. Mullins and

her firm are counsel for three individual plaintiffs, all in North Carolina, whose claims have been

referred to the MDL. Moreover, and as further discussed in Exhibit B (attached), she has

significant multidistrict experience, including serving as trial counsel for bellwether cases in *In re*:

C.R. Bard Inc., Pelvic Repair System Products Liability Litigation, MDL No. 2187.

3. We understand that Ms. Mullins has accepted this recommendation and is willing

to serve in this important role if appointed by the Court. We therefore jointly and unanimously

recommend Ms. Mullins and respectfully request that the Court appoint her to serve as Plaintiffs'

Liaison Counsel in this matter.

4. In accordance with the Court's First Pretrial Order, a current CV for Ms. Mullins

is attached as Exhibit A. Attached as Exhibit B is a statement that summarizes Ms. Mullins'

educational background, licensing status, relevant experience, and addresses the rates that she

would request for her work as liaison counsel, if appointed.

EXHIBIT B

Allison Mullins

Allison Mullins graduated from Wake Forest University, *cum laude*, in 1993. She earned her law degree, also *cum laude*, from Wake Forest University School of Law in 1996. Among other things, she was Order of the Coif, Articles Editor of the Wake Forest Law Review, and a member of a competition appellate team. She was admitted to the North Carolina Bar in 1996 and has been a member in good standing since that time.

Immediately following law school, Ms. Mullins clerked for the Honorable N. Carlton Tilley, Jr. in the United States District Court for the Middle District of North Carolina. In an early introduction to high profile litigation, Ms. Mullins was Judge Tilley's clerk during the *Food Lion v. ABC* trial in 1997. Following her clerkship with Judge Tilley, Ms. Mullins clerked for the Honorable Susan H. Black in the United States Court of Appeals for the Eleventh Circuit. After completing these clerkships, in 1998, Ms. Mullins joined Smith Helms Mulliss & Moore (later Smith Moore Leatherwood, now part of Fox Rothschild) in Greensboro, North Carolina where she practiced for 15 years. In 2013, along with three partners, Ms. Mullins (then Allison Van Laningham) formed Van Laningham Duncan PLLC d/b/a Turning Point Litigation (now Mullins Duncan Harrell & Russell PLLC d/b/a Turning Point Litigation). Turning Point Litigation was formed as a litigation boutique, focusing on complex trial and appellate matters. She continues to practice in the firm today.

Ms. Mullins' practice focuses on jury trials and appeals in complex commercial and civil matters, including representation of individuals who are injured by another's negligence. She has amassed trial experience in cases that involved a variety of subject matters. In early 2012, Ms. Mullins was retained by Senator John Edwards to defend him in a criminal campaign finance trial that was to begin in little more than a month. During the trial, she presented the

opening statement as well as examined and cross-examined witnesses. Ms. Mullins and the three-lawyer trial team of which she was a part were successful in their defense of Senator Edwards.

Ms. Mullins is widely recognized for her skills as a lawyer and a litigator, having received numerous professional accolades. She is a Fellow in the American College of Trial Lawyers. She is recognized among the Benchmark Top 250 Women in Litigation. She is consistently named to "top" lists by SuperLawyers, Best Lawyers, Legal Elite, and other professional groups and organizations.

In February 2013, Ms. Mullins was contacted by a Lead Counsel in the transvaginal mesh MDL then pending before the Honorable Joseph R. Goodwin of the Southern District of West Virginia. She was invited to join the trial teams for the bellwether trials in the Bard MDL, with the first bellwether trial set to begin only a few months later in July of 2013.

Ms. Mullins became a key member of the trial teams for the Bard bellwether trials, with the first bellwether resulting in a multi-million-dollar verdict for the plaintiffs. A primary focus of her work was preparing the plaintiffs (women and men) for their trial testimony. This was an arduous task, as the plaintiffs would be called on to relay very intimate and private details of the damage they suffered as a result of Bard's mesh product in a heartfelt manner, while also being prepared to stand against the onslaught of cross examination. She traveled throughout the country meeting multiple times with each bellwether plaintiff. In addition to serving as a trial team member for all of the Bard bellwether trials, Ms. Mullins worked with MDL leadership to develop themes and strategies for the MDL as a whole. She also deposed multiple Bard corporate witnesses, a Bard expert, and the Rule 30(b)(6) representative from a company that was a key part of the Bard mesh supply chain. When Judge Goodwin directed the parties to

conduct discovery in large groups of cases denominated as "wave" cases, Ms. Mullins was very involved as well, deposing numerous witnesses (including implanting and explanting physicians) and preparing numerous plaintiffs for their depositions. Ms. Mullins also was actively involved with the important Fourth Circuit appeal and defense of the initial bellwether verdict.

If appointed as Plaintiffs' Liaison Counsel in the Gardasil MDL, Ms. Mullins requests and would accept \$550 per hour for her work.
